

CALL FOR NOMINATIONS 2024 BOARD OF DIRECTORS

Uptown Dallas Inc. (UDI) is the non-profit organization that operates the Uptown Dallas Public Improvement District (UPID). Our job is to manage and enhance the public improvements of the Uptown district. We are funded by special assessments paid for and voted on by Uptown property owners.

PIDs are mechanisms commonly used in many cities to fund and manage services and improvements in specific areas beyond what is provided by the city government. The specific goals and activities of the Uptown Dallas PID may evolve over time, but its primary purpose is to enhance the overall quality of life and economic vitality of the Uptown neighborhood through targeted investments and improvements. These efforts are typically funded through assessments on property located within the PID boundaries, which provide a dedicated source of revenue. Active since 1993, Uptown Dallas Inc. celebrated 30 years this year.

Board of Directors

The Board of Directors shall be comprised of individuals who are, or represent, owners and renters of real property located in the Uptown Public Improvement District. Board members are vetted and determined eligible by the Nominating Committee of the Board. A slate of potential Board members will be presented to the Board of Directors for approval in November of each year and terms begin January 1. Directors shall be elected each year to serve a two (2)-year term. The nominating committee is committed in our attempt to identify a diverse pool of candidates reflecting the diversity of the population we serve in Uptown.

Directors are expected to support the organization by:

- regular attendance at meetings of the board;
- service on a committee of the board;
- carrying out its fiduciary responsibilities such as reviewing the organization's financial statements; and
- advancing the work of UDI throughout the community.

Directors are asked to adhere to a Board Code of Conduct, Conflict of Interest and Confidentiality Statement. New Directors will be required to attend an orientation session prior to serving. Board meetings are held the third Thursday of every other month (Feb – Dec.). Committee meetings vary.
