- Maintenance Committee

- McKinney Avenue Transit Authority ("MATA") Committee
  - Neal Sleeper, UDI MATA Chair, reported that MATA continues to operate at record levels.
- Public Realm and Capital Improvements Committee

- Public Safety Committee
  - Kelem Butts reported on the public safety initiatives in response to the current public safety concerns. Overall crime is down 23%. Tier One Security began patrolling the neighborhood since January 1.
  - Joseph Pitchford presented on the Uptown Success Alliance (USA) requests funding of \$170,000 for direct expenses related to supporting Councilmember Ridley's SUP Overlay efforts.
